# **MAJOR PURPOSE:**

William Jessup University invites applications for a full-time tenure track appointment in biology at the assistant or associate rank, starting in the fall of 2024. Responsibilities will include teaching 3 courses per semester including; anatomy, physiology, pathophysiology, genetics, as well as other courses in the field of human biology that play to the candidate's expertise, interests, and experiences. Research interest and application will be a significant component of this position.

We encourage applications from members of historically underrepresented groups. All qualified applicants will receive equal consideration regardless of race, color, national origin, sex, disability, age, or veteran status.

The pay range for this position is generally: \$65,000 - \$85,000 annually. Individual pay is determined by a number of factors including relevant education and training, academic and related experience, high demand disciplines, location, and job-related skills.

This position is 100% in person, on campus.

# **ESSENTIAL FUNCTIONS:**

- This candidate will help guide and develop a master's degree in biology as well as serve as an advisor for American Medical Student Association (AMSA)
- Additional teaching may include upper-level courses in the candidate's area of expertise that support and complement current departmental offerings.
- Provide timely, specific, and helpful feedback to students regarding performance in the course
- Participate in scholarly activity that involves undergraduate students, including participation in professional development and research activities in order to remain academically current and relevant.
- Serve on University committees as needed
- Provide instruction, remediation and evaluation in didactic and clinical learning concepts including coordinating and supervising students to ensure that lab experiences meet course objectives.
- Demonstrate effective behaviors and accountability in accordance with standards of service excellence to students, fellow team members, and external agencies.
- Contributes to and attends national academic and clinical learning conferences
- Coordinates and supervises students to ensure that lab experiences meet course objectives; provides individual oversight to students for practice and/or remediation on technical skills as requested by faculty and students.
- Participates in planning and scheduling for students and faculty by ensuring open lab and structured lab utilization times are available and communicated and appropriately resourced.

### WORKING ENVIRONMENT:
